1. The Ministry of Commerce & Industry has received additional budgetary allotment from the Government of Liberia and it intends to apply part of the proceeds to payment under the Contract for Renovation works in two lots below:

Lot 1: Renovation of the Liberian Market Place located within the Nancy B. Doe, Jorkpen Town Market on 8th Street, Tubman Boulevard, Sinkor. This project is phase two of the renovation works at the Nancy B. Doe facility and will cover painting of the two sides and back of the building including other construction works as stated in the bidding document.

Lot 2: Two buildings at the (MIP) Monrovia Industrial Park (main Office building and a security Office building). Get a copy of bidding document for more detail. Bidders can apply for either of the lots or both.

- **2.** The Ministry of Commerce now invites reputable construction firms to carry on assessment in and around the building mentioned above and after which submit sealed bids for Renovation works.
- 3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures approved by the Public Procurement and Concessions Commission (PPCC) specified in the Public Procurement and Concessions Act (PPCA) and is opened to all bidders as defined in the Bidding Documents.
- 4. All interested eligible bidders may obtain further information concerning bidding from the Procurement Unit; 3rd Floor; Ministry of Commerce & Industry, Ashmun & Gurley Streets between 10:00am-3:30PM Monday-Friday
- 5. Qualifications requirements include:
 - Applicant must be registered with the Public Procurement and Concessions Commission (PPCC) evidence by being logged on the PPCC data base and attach any other supporting documents
 - Business Registration, Tax Clearance certificate,
 - Association of Liberian Construction Company (ALCC) and Public Works Certificates
 - See Bid Data Sheet for additional requirements.
- 6. A complete set of Bidding Documents can be picked up from the Procurement Unit for a nonrefundable fee of 50.00 USD.
- 7. Bids must be delivered in sealed envelope to the address below on or before **Friday**, **June 30, 2017 at 1:00 pm.** Electronic bidding shall not be permitted. Late bids will be rejected. Bids will be opened in the presence of bidders' representatives who choose to attend on **June 30, 2017 at 1:00 pm in the MSME Conference Room.**

- 8. All bids shall be accompanied by a Bid-Securing Declaration as described within the Bidding Documents. Please note that bidders must declare for the period of three (3) month.
